UGC approved, 1<sup>st</sup> cycle NAAC accredited college affiliated to Baba Saheb Ambedkar Education University (BSAEU) (Erstwhile WBUTTEPA), is a West Bengal Government aided college, having its campus at shimurali, Nadia, West Bengal, represented by its Principal Dr. Ahana Chakraborty, daughter of Late Monoj Kumar Chakraborty and Late Maya Chakraborty, herein after referred to as the SECOND PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns) **OF THE OTHER PART.**

Both the institution hereinafter referred to as Parties.

**Purpose of the agreement:**

Both the parties are pleased to enter upon an agreement to established ties of academic co-operation in order to contribute to the achievement of their overall goals as institution through following but not limited to:

1. Joint teaching and exchange projects.
2. Collaboration in the area of academic publications, research activities, field trips etc.
3. Visit, training and exchange of faculty, staff and students.
4. Joint educational/vocational courses.
5. Joint consultancy, Ph.D. supervision and scientific publications.
6. Co-hosting and participation in conferences, seminars, symposiums and workshops.
7. Social and Cultural programs.
8. Games and sports.
9. Any other activity that is mutually agreed upon and is beneficial to both.

**III. Execution of the Agreement:**

The specific activities to be carried out under the agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexure to this agreement. The specific sub-agreements between both parties will specify their objectives, conditions and ways of execution, financial support, period the sub-agreement will be in effect, and administrative responsibility within each institution.

**IV. Term and Expiration of the Agreement:**

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of five years. After five years, it will be automatically extended for same period, unless one of the Parties expresses an intension (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination and expiration of this MOU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the parties.

Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notice shall be in writing and shall be directed to these representatives.

**V. NON-EXCLUSIVITY:**

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

**VI. SPECIAL PROVISIONS:**

Each party will take approval from the other party in writing prior to using the latter's name and logo for the activities hereunder on a case-by-case basis.

All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.

The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MOU or any subsequent associated agreement informally.

Neither party can misuse this MOU by involving the name of the other without the written consent from the other party.

## VII. DISPUTES:

If any dispute arises in respect of the MOU, in that case both the organizations will discuss and settle the matter amicably.
